The purpose of this Agreement is:

- to recognise that in being chosen as a part of the team you are undertaking to represent your country overseas;
- to ensure that you understand and agree with the obligations that you have while you are a New Zealand Representative;
- to ensure you will not bring either yourself or the New Zealand Ice Figure Skating Association into disrepute;
- to ensure that you conform to the ISU and NZIFSA Rules and Code of Ethics;

Set out here are your responsibilities during the term of this Agreement:

You agree to do the following:

1. to behave in a manner consistent with the standards of performance expected of a national representative;
2. to do nothing which could harm the reputation of the New Zealand Ice Figure Skating Association;
3. to be bound by the Constitution, Rules, Regulations, Policies and Code of Ethics of the NZIFSA, ISU, NZ Olympic Committee and the International Olympic Committees;
4. to be familiar with and comply with the WADA Anti-Doping Policy;

As a member of an official team you also agree to do these things:

1. to be present at any time designated by the team leader for meals, training sessions and competition;
2. to abide by any curfew instructions given and to respect at all times the need of your room-mates and neighbours for rest and privacy;
3. to wear the New Zealand jacket or other official clothing if provided whilst at competition and ceremony events, and to dress appropriately at any other official occasions;
4. to cover all your personal costs incurred at the team hotel and during the competition, and to ensure that you have the necessary resources to do this.

Other obligations you have as a New Zealand Representative:

1. you must at all times show good sportsmanship towards all team members;
2. you are expected to show support for and solidarity with other New Zealand representatives
3. you must observe all the laws and regulations of the host country, including in regard to the consumption of alcohol, and in any case you must not indulge in unreasonable behaviour that brings you or your team into disrepute. The Board of the NZIFSA reserves the right to impose disciplinary measures in the event of unacceptable behaviour.

Disciplinary Procedures:

In signing this Agreement you are agreeing that the NZIFSA has the right to undertake reasonable disciplinary measures, including suspension from the team, withdrawal from the competition or future competitions, and restrictions or suspensions on future selections or accreditation.

Disciplinary measures will follow these steps:

Within reason and where practicable, disciplinary procedure will be proceeded by written notice from the NZIFSA.

If for reasons of time and/or location it is not practicable to give written notice, the team leader will impose disciplinary measures which are appropriate to the offence. If there is no team leader, the senior NZIFSA official present will act in that capacity.

If the responsible official determines that you should be sent home, this will occur as soon as arrangements can be made. You will be responsible for any additional costs.

Travel and competition:

You acknowledge that skating carries a risk of physical injury. You agree to take all reasonable care to avoid causing harm to yourself and others;

You accept the risk and consequences that may arise in connection with skating, including travel to and from competitions and over-night stays.

You are required to carry travel medical insurance. You agree that it is your responsibility to pay for or reimburse the NZIFSA or ISU for any medical expenses incurred for yourself.
